You have been issued a Commonwealth of Kentucky Uniform Citation. About two-thirds of the way down and on the left of the citation the officer has assigned a court date and time for you and has checked either "Payable" or "Court."

If the officer checked "Court" **YOU MUST APPEAR IN COURT** on the day and time assigned by the officer. Court is held at 600 Columbia Street, Newport, Kentucky in courtroom #1.

If the officer checked "Payable" **YOU MAY PRE-PAY THE CITATION** two (2) working days prior to the court date assigned by the officer. You may pay the citation in person or by mailing a check or money order made payable to the **Campbell County District Court**, along with a copy of the citation, to the above address. Office hours are from 8:30 a.m. to 4:00 p.m. **Add \$10.00 to the amount, if paid late.**

By pre-paying your citation you are admitting guilt and you waive your right to a court hearing. If you want to contest the citation or if you do not pay the amount due two (2) days before your assigned court date, your name will appear on the court docket for that day and you will be expected to appear in court.

The cost of payable offenses is set and regulated by law. All payable violations, except speeding and those listed below, are set at \$156.50. The cost of the speeding violation is governed by the following schedule, unless you were speeding in either a school zone or a highway work zone. In those cases please call the office to get the total fine amount.

If you are also charged with not wearing a seat belt, please add \$25.00 to the amount of the primary violation. For example, if you were charged with speeding, 15 mph over the limit and with not wearing your seat belt, your total fine would be \$191.50 (\$166.50 for speeding and \$25.00 for not wearing your seat belt). If you are charged with only not wearing your seat belt, your total fine is \$25.00. If you are charged with expired registration or no registration, your total fine is \$156.50. **Handicapped parking violations KRS 189.459(2) and 189.459(3) cost you \$250.00 for each offense. Child Restraint violations KRS 189.125 cost you \$186.50 for each offense.**

It is important that you take this matter seriously as KRS 186.570(1)(h) states that the Transportation Cabinet may suspend the driver's license of any person, when they have reason to believe that person has failed to appear in court (or failed to pay) pursuant to a citation issued by a law enforcement officer of the Commonwealth of Kentucky or another jurisdiction.

If you have a Kentucky driver's license and wish to attend State Traffic School (STS), please call 859-292-6305 **before** you pay your citation. Attending STS, if you are eligible, will reduce your fine and prevent points from appearing on your Kentucky Driving Record as a result of a conviction of a moving violation.
